- ◆ Do you understand that this Wastewater Service Agreement does not change but only adds to what you already agreed to when you became a member of North Alamo Water Supply Corporation?

- ◆ Do you understand and agree that sometime in the future, NAWSC may require a right-of-way easement over and across your property for the purpose of installing sewer facilities and your refusal to grant such easement of such form, as may be required by NAWSC, will result in discontinuance of your water service and cancellation of your NAWSC membership?

- ◆ Do you understand and agree that the Corporation is responsible for **all maintenance costs outside** of your property line and that you are responsible for all maintenance and structural costs **within** your property lines?

- ◆ Do you understand that you will have to pay for all structural costs to connect your wastewater service **off and on** your property?

- ◆ Do you understand that the charge to connect your wastewater service must be agreed to and paid for before any work to connect your service can begin?
