APPLICATION FOR WATER SERVICE

Completed Applications for Water Service are accepted Monday through Friday from 8:00 AM to 4:30 PM in the New Accounts Department of our Corporate Office.

- ◆ Only the property owner (not tenant) may fill out an Application for Water Service.
- ◆ Applicant must provide North Alamo WSC with a copy of the property deed to show proof of ownership at the time of application.
- ◆ Applicant should carefully read and sign the Service Agreement before turning in the Application for Water Service.
- ◆ Applicant must provide the appropriate permit before service can be provided:
 - Hidalgo County
 - Property located outside city limits that have septic tanks: Applicant must obtain one (1) permit from the Hidalgo County Planning Department which is located at 1304 S. 25th St, Edinburg, TX. Please contact their office at (956) 318-2840.
 - Property located within city limits: The city in which the property is located will provide applicants with the appropriate permit(s).
 - Willacy County
 - Applicant will need to provide a building permit from the Willacy County Courthouse annex building in Raymondville. Please contact the county inspector at (956) 689-3393 for information.
 - Cameron County
 - Applicant will need to obtain one (1) permit from the Cameron County Environmental Health Department. Please contact Jesse Silva (956) 247-3606 or Richard Castillo (956) 247-3604 for information.
- ◆ Applicant will need to place a stake on the property where the water meter is to be located. The stake should be at least three (3) feet tall with the property owner's name painted legibly on the stake. Wherever the stake is placed will be where the water meter is installed. If the water meter ever has to be relocated, the applicant is responsible for paying the cost of the relocation.
 - North Alamo WSC must have access to the water meter at all times. Fences, landscaping, dogs, driveways, etc. should be carefully considered prior to placing the stake on the property. If there are plans to build a fence, the plans must include access to the water meter. If a fence is already in place, the fence must be altered in such a way that would allow our repair and meter

departments access to that meter at all times. Keeping a meter box free of litter and debris is the responsibility of the applicant/member. In addition, applicants/members must not tie up dogs near the water meter.

- ◆ If the property is not in a subdivision, please use the map diagram contained within the Application for Water Service to indicate the nearest crossroads in proximity to the property.
- ◆ If the applicant has a water-related emergency, please furnish documentation from a medical physician stating the water-related emergency.
- ◆ If the developer of the subdivision for the property has provided the applicant with a pre-paid letter, that must be submitted to North Alamo WSC for retention in the file. The letter would replace the amount of the membership cost, and the applicant would then only be responsible for paying the cost of the inspection.
- ◆ Applicant must provide a copy of a picture ID or Driver License.

**NORTH ALAMO WATER SUPPLY CORPORATION
SERVICE AGREEMENT**

AGREEMENT made on this _____ day of _____, 20 _____ between North Alamo Water Supply Corporation, a Corporation organized under the laws of the State of Texas (here in after call The Corporation) and _____.

The Corporation agrees to sell and deliver water to the Member and Member agrees to purchase and receive water from the Corporation, for general farm use and domestic purposes, in accordance with the bylaws and rules of the Corporation as amended from time to time by the Corporation's Board of Directors.

The member shall pay the Corporation for service hereunder at the rates and upon the terms and conditions set forth in the rate schedule adopted from time to time by Corporation's Board of Directors The Board of Directors shall have the authority to cancel the membership of any member in the event of nonpayment of any water charges or assessments owing by said member within thirty (30) days after demand for payment by mail, properly addressed to such delinquent member.

All water shall be metered by Water Meters furnished and installed by the Corporation.

In the event the total water supply shall be insufficient to meet all the needs of the Members, or in the event there is a shortage of water, the Corporation may pro-rate the water available among the various Members on such basis as is deemed suitable by the Board Of Director, and may also prescribe a Schedule of hours covering the use of water for any purposes by particular Members and require adherence thereto or prohibit the use of water for any purposes; provided that, if at any time the total water supply by insufficient to meet all the needs of all the members the Corporation must first satisfy all the needs of all Members for domestic purposes before supplying any water for livestock purposes and must satisfy all the needs of all Members for both domestic and livestock before supplying any water for garden purposes.

The member shall allow his property to be inspected for possible cross-connections and other potential contamination hazards. These inspections shall be conducted by the Corporation or its designated agent prior to initiating new water service; when there is reason to believe that cross-connections or other potential contamination hazards exist; or after any major changes to the water distribution. No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an air-gap or an appropriate backflow prevention device. No cross-connection between the public drinking water supply and a private water system is permitted. No connection which allows water to be returned to the public drinking water supply is permitted. No pipe or pipe fitting which contains more than 25.0% lead may be used for the installation or repair of plumbing at any connection which provides water for human use. No solder or flux which contains more than 0.2% lead can be used for the installation or repair of plumbing at any connection which provides water for human use.

The Member shall install and maintain at his own expense a service line from the meter to the point of use. The Member shall hold the Corporation harmless from any and all claims or demands for damages to real-estate or personal property occurring from the point of Member ties on to the Corporation meter to the final destination of the line installed by Member. The Member agrees to grant to the Corporation an easement of right-of-way for the purpose of installing, maintaining, and operating such pipelines, meter valves and any other such equipment which may be deemed necessary for the Corporation on such form as is required by the Corporation. Failure to provide such requested easements may result in the termination of water service.

The Corporation shall have the right to locate a water service meter and pipe, necessary to connect the meter on the property of the Member at a point to be chosen by the Corporation and shall have access to its property on the Member's premises at all time for any purpose connected with or in the furtherance of its business operations, and on discontinuance of service shall have the right to remove any of its property from the Members premises.

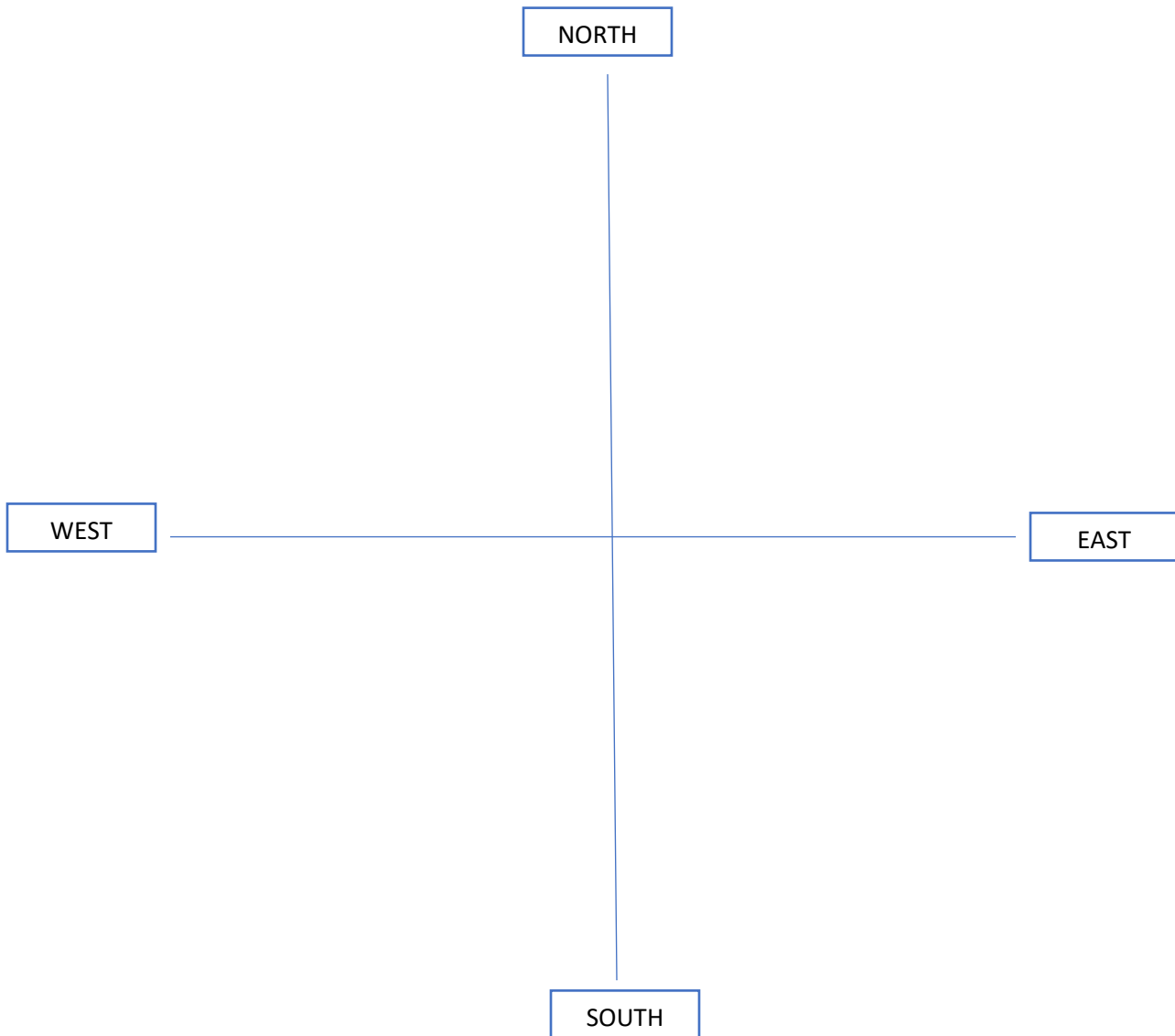
If the customer fails to comply with the terms of the Service Agreement, the Corporation may at its option, either terminate service or properly install, test, and maintain an appropriate backflow prevention device at the service connection. Any expenses associated with the enforcement of this agreement shall be billed to the customer.

INFORMATION DISCLOSURE

The records of the Corporation shall be kept in the Corporation office in Edinburg, Texas. All information collected, assembled, or maintained by or for the Corporation shall be disclosed to the public in accordance with the Texas Public Information Act and other applicable law. **In no event and under no circumstances shall the Corporation disclose the Social Security Number of any member or customer to any person other than an employee of the Corporation.** Chapter 182, Subchapter B of the Texas Utilities Code makes confidential a water utility customer's address, telephone number, account records, and information relating to the volume or units of utility usage, or the amounts billed to or collected from the individual for utility usage. **However, an individual customer may request in writing that his information be released upon request.**

The confidentiality provision in Chapter 182, Subchapter B of the Texas Utilities Code does not prohibit the utility from disclosing this information to an official or employee of the state or political subdivision of the state acting in an official capacity or an employee of the Corporation acting in connection with the employee's duties. Further, such confidentiality does not prohibit the Corporation from disclosing the name and address of each member entitled to vote on a list to be made available to the Corporation's voting members, or their agents or attorneys, in connection with a meeting of the Corporation's members.
