# General Information

NORTH ALAMO WSC provides surface water and ground water from the Rio Grande located in Gulf Coast.

## Information about your Drinking Water

The source of drinking water, tap water, include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. ### Contaminants that may be present in Source Water Include:

#### Microbial Contaminants

Such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

#### Inorganic Contaminants

Such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges oil and gas production, mining, or farming.

#### Pesticides and Herbicides

Which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

#### Organic Chemical Contaminant

Including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas station, urban storm water runoff, and septic systems.

#### Radioactive Contaminants

Which can be naturally-Occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. <b>Definition and Abbreviations:</b>	The following tables contain scientific terms and measures, some of which may require explanation.
<b>Avg:</b>	Regulatory compliance with some MCLs are based on running annual average of monthly samples.
<b>Action Level:</b>	The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
<b>Action Level Goal (ALG):</b>	The Level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of Safety.
<b>Maximum Contaminant Level or MCL:</b>	The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
<b>Level 1 Assessment:</b>	A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
<b>Maximum Contaminant Level Goal or MCLG</b>	The level of a contaminant in drinking water below which there is no know or expected risk to health. MCLGs allow for a margin of safety.
<b>Level 2 Assessment:</b>	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E.coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
<b>Maximum residual disinfectant level or MRDL:</b>	The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants
<b>Maximum residual disinfectant level goal or MRDLG:</b>	The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
<b>MFL:</b>	million fibers per liter (a measure of asbestos)
<b>na:</b>	not applicable
<b>Mrem:</b>	Millirems per year (a measure of radiation absorbed by the body)
<b>NTU:</b>	nephelometric turbidity units (a measure of turbidity)
<b>pCi/L:</b>	picocuries per liter (a measure of radioactivity)
<b>ppb:</b>	micrograms per liter or parts per billion– or one ounce in 7,350,000 gallons of water.
<b>ppm:</b>	milligrams per liter or parts per million– or one ounce in 7,350 gallons of water.
<b>Treatment Technique or TT:</b>	A required process intended to reduce the level of a contaminant in drinking water
<b>ppt:</b>	parts per trillion, or nanograms per liter (ng/L)
<b>ppg:</b>	parts per quadrillion, or picograms per liter (pg/L)

Information Statement: Turbidity is a measurement of the cloudiness of the water caused by suspended particles. We monitor it because it is a good indicator of water quality and the effectiveness of our filtration and disinfectants.
